Alumni Awards 2023

- The Distinguished Alumnus Award (DAA) will be the highest award given by St Vincent Pallotti College of Engineering & Technology (SVP CET), Nagpur to its alumnus in recognition of their achievements in their respective field of expertise.
- The Young Alumni Achiever Award (YAA) will felicitate the achievements of young alumni who have shown promise and early success in their professional journeys. Also to encourage awardees to achieve further excellence in their chosen careers, this recognition is designed to further strengthen their relationship with their alma mater.
- The awards (DAA & YAA) will identify the individuals who can later contribute time, professional experience and resources towards the success of our future technocrats, through mentorships, skill development, industry and research collaboration, and other guidance.
- The Alumni Cell will receive the nominations under specific categories for the Alumni Awards (DAA / YAA) and the selection will be made by a screening committee appointed by the Hon. Director of SVP CET.
- 10 alumni will be selected for the awards each year and awards will be conferred either during annual alumni meet at SVP CET or during graduation ceremony.

Objective of Awards:-

- To recognize and honor the professional achievements and contribution of our alumni in their respective field of expertise.

Eligibility: - Any graduate who has completed a regular degree course from SVPCET is eligible to be considered for Distinguished Alumnus Award (DAA) and Young Alumni Achiever Award (YAA)

- An alumnus who has already received Distinguished Alumnus Award or Young Alumni Achiever Award may only be considered for Distinguished Alumnus Award after a period of five years from the date of receipt of the former.
- The nominees may please note that the Awards will be bestowed on Alumnus with a highest degree of professionalism and ethics.
- The conduct and behavior of such awardees should bring respect and laurels to the institute and should never cause disrepute to the institute.
- In view of the above, DAA and YAA award winners may please note that the Institute has the right to rescind and withdraw such award(s) if at any future point of time it is brought to the notice of the institute that the character and conduct of any such awardees is not conducive nor in tune with general norms of propriety, integrity and honesty in society.

Category of Awards:-

A] Distinguished Alumnus Award (DAA):-

Eligibility:-

- Minimum 10 years of Professional Experience after graduation from SVPCET.
- Batch pass out from 2008 to 2013.
- Total Awards to be awarded in this category: - 05

B] Young Alumnus Achiever Alumnus Award (YAA):-

Eligibility:-

- Minimum 5 years of Professional Experience after graduation from SVPCET.
- Batch pass out from 2014 to 2018.
- Total Awards to be awarded in this category: - 05

Criteria of Awards:-

1. Technology Innovation Excellence:-

Innovations in application of technology, design & development achievements, awards & recognition (external & internal), technical leadership activities & positions, fellowships in professional organizations, patents & publications, industry standards activities, collaborations with academia, community service

2. Managerial Excellence:-

Exceptional management skills, leadership position with company/ organization , awards & recognition, Board memberships, Fellowships, testimonials, global stature, Collaborations with academia, community service, service to nation ,team leadership in setting up new enterprises, mentoring track-record.

3. Entrepreneurial Excellence:-

Significant entrepreneurial skills & accomplishments, creation of support structure for entrepreneurs, success of start-ups in establishing market presence, scale of operation & reach to society, awards & recognition, coaching & advisory activities.

4. Academics / Research, Scientific Innovation:-

Academic achievements and honors, intellectual contributions to the field of expertise, pioneering work, journal papers & citation indices, conference papers, books and book chapters, visiting professorships, lectureships, fellowships in professional associations, student mentoring & welfare activities, peer testimonials, awards & recognition

- Rubrics for award will be based on above criteria's and category's in which nominations are received.
- Award will include a memento and a certificate.

Nomination Guidelines:-

- Self Nominations may be made online for an Alumnus Awards (DAA and YAA)
- Nomination for DAA and YAA awards will be valid for 1 year
- Re- nomination is allowed at the end of 1 year of validity.
- Nomination in maximum two criteria's specified is allowed
- Separate nomination forms to be submitted in such cases.
- Nomination form will be accepted using the following guidelines:

Nomination Form in the prescribed form with all the credentials of the nominee.

It should include details and specific examples that will help the screening committee understand the significance of nominee's accomplishments in terms of:

a) Impact, b) Influence, c) Other awards and accolades and d) How the alumnus efforts bring distinction to SVP CET

In addition to the above Nomination Form, nominees are encouraged to provide supporting items that further distinguish the nominee. Such items include, but are not limited to:

- Current curriculum vitae of the nominee
- Professional honors, Awards or certificates of achievement / commendations
- Membership / leadership in professional organizations
- Publications, or noteworthy special work
- Newspaper and magazine articles / profiles / personal success stories
- Other items of interest
- Name of 1 reference person
- Reference's may be from the following :-
- Any member / office bearer of the SVP CET Alumni Association or its chapters
- Any member of the administration and faculty of SVP CET.

Method of Award Recipient Selection

- Nominations shall be shortlisted by a Screening Committee (SC) chaired by the Member of Management Committee to be constituted with the approval of Hon. Director, SVP CET
- Shortlisted nominations shall be peer reviewed.
- Based on the recommendations of the peer reviewers, the SC will make a recommendation for consideration to the Director, SVP CET
